Terms of Reference:

- Guide the Apex Council regarding feasibility with technical inputs for creation of cricket infrastructure in different District Associations forwarded by Apex Council to the sub-committee for appraisal etc.
- Provide technical details on each proposal both new and existing accepted in principle by Apex Council. Forward proposal to Apex Council for engagement of surveyors, architects etc., if any required for the purpose of formulation detail drawings, estimate etc.
- Prepare detail Action Plan for preparation of existing ground(s) both at HQ and District Level well in advance, before commencement of cricket season together with detail estimate etc., supported by justification for the same.
- Prepare inventory of existing machines and equipment's available both at Shillong and other District Associations like Tura etc. Furnish proposals for purchase of new ground equipment's if necessary, including repair etc., of existing ones on discussion with respective Curators. Prepare format for daily maintenance records of ground equipment's including maintenance of records relating to utilisation of POL, lubricants etc., followed by periodic monitoring of records and compilation of monthly report.
- Submit proposal to Apex Council allotment of ground for different BCCI and MCA tournaments in consultation with Game Development & BCCI Tournaments etc., sub-committee and Tournament sub-committee.

- Facility of players including placing before the Apex Council any genuine issues, problems of players including injury and insurance matters etc., particularly organizing the BCCI age verification/AVP process, bone tests etc., well in advance before commencement of season.

Monitoring of matches, including documentation of all data and statistics of all matches shall be the responsibility of the Tournament Committee.
